At the CFBPW Annual Conference Linda Wilson gave an update on the Equal Rights Amendment now that Nevada has ratified it and what CFBPW members can do to finally get it ratified. Remember the Equal Rights Amendment is number one on our Public Policy Statement.

We need to remove the deadline for ratification of ERA in Congress. HJ Res. 53 Speier (CA-D) and SJ Res.5 Cardin (MD-D) would do that. HJ Res 53 has 156 co-sponsors (all Democrats). This is an increase of twelve since Nevada ratified the ERA. More co-sponsors would help to get the bill passed. The Democrats support ERA in their platform. It would be great to have some Republican co-sponsors. Following are the California Congress-members, who are not a co-sponsor of the bill. If you live in the following California Districts, contact your Congressmember to co-sponsor this bill to extend the deadline to ratify the ERA – 1st District Doug LaMalfa; 4th District Tom McClintock; 7th District Ami Bera (who is a Democrat); 8th District Paul Cook; 10th District Jeff Denham; 12th District Nancy Peloski (who is a Democrat); 16th District Jim Costa (who is a Democrat); 19th District Zoe Lofgren (who is a Democrat); 20th District Maxine Waters (who is a Democrat); 39th District Ed Royce; 42nd District Ken Calvert; 43rd District Maxine Waters (who is a Democrat); 45th District Mimi Walters; 46th District Luis Correa (who is a Democrat); 48th District Dana Rohrabacher; 49th District Darrell Issa; 50th District Duncan Hunter. The 34th Congressional District, depending upon June 7th election. This bill is in the House Judiciary Subcommittee on Constitution and Civil Justice.

The comparable Senate Bill SJ Res 5 has 30 co-sponsors (one Independent and the rest are Democrats). Both California Senators are co-sponsors. This bill is in the Senate Judiciary Committee. Let's work on ratifying the ERA before 2020 when the NFBPWC is hosting the BPW International Congress in Orlando, Florida. This is Liz Benham, our National President's goal.

FOCUS: HUMAN TRAFFICKING

What a wonderful weekend to have a conference! Our CFBPW federation is beginning its 97th year as advocates for women and August 26th is the anniversary of WOMEN'S EQUALITY DAY. It is time for our members to attend, to celebrate and be informed.

On Saturday, luncheon speakers will discuss a subject our members have been following: HUMAN TRAFFICKING. Our federation has invited once again, OPAL SINGLETON, an expert in Human Trafficking and Child Pornography. She will share the updates that we need to be aware.

We will also meet a victim of HUMAN TRAFFICKING. Our speaker is an example of how one person's story of tragedy can turn to triumph despite unthinkable and often unspeakable challenges. Meet MARIA SUAREZ! Maria, who is from Mexico, met a woman who asked if she wanted a job to help an elderly couple with cleaning. She said yes and years of torment followed. She was bought by her employer and held captive as his slave for more than five years and then sent to prison for 23 years for a crime she didn't commit. She is now sharing her personal story to help others avoid human trafficking.

WOMEN LEADERS SHARE THEIR POLITICAL JOURNEY

After the break in the afternoon, we meet Women Leaders of the Inland Empire who will share their political journeys and then serve on a panel, led by Lynn Brandstater, CFBPW Vice President.



Screening Committee Update (070417)

AB-229, Baker Human Trafficking – Vertical Prosecution Program Support Establishes appropriation of \$2,600,000 from the General Fund to provide vertical prosecution in up to eleven district attorney offices through 2022 through the Office of Emergency Services to allocate and award funds to communities developing and providing ongoing citizen involvement and crime resistance program. Certain conditions are established for providing statistics to the Legislature and the Office of the Governor of special criteria and reporting.

Status: 070317 Action from the Committee Chair with co-authors amendments. Amend and re-refer to committee. Read second time, amended and re-referred to Senate Committee on Appropriations.

 AB-260, Santiago
 Human Trafficking – Posted Notice
 Support

 This bill would require hotels, motels, bed and breakfast inns and other similar transient
 lodgings establishments to add to the current list of businesses a required posting of in

 formation regarding slavery and human trafficking.
 Status:

070317 032317 referred to Senate – Read for first time. 051017 referred to the Committee on Judiciary. 070317 from Committee, amended and passed as amended. To Consent Calendar. (see next page....)

Screening Committee Update (070417)

- AB-372, Stone Domestic Violence Probation Support
 This bill would require the goal of a batter's program to stop domestic violence through the use of evidence-based or promising practices, that have demonstrated success in addressing the criminogenic needs of batterers and would add additional program requirements to ensure this outcome. Status:051517 referred to Senate 061917 Amend and re-ferred to committee on Public Safety. Read second time, amended and re-referred to Committee on Public Safety. 062717. Set for hearing.
- AB-1731, Atkins Human Trafficking

This bill is no longer authored by Atkins. Bill is now a requirement for the California Colleges Chancellor's Office to provide guidance to local educational agencies on the allocation and oversight of apprenticeship training funds.

Support

- SB-169, Jackson and De Leon Discrimination: Federal Title IX Support
 This bill would express the intent of the Legislature that each local educational agency, and would require the appropriate governing local body of each higher education institution that receives state funds for student financial assistance to designate at least one employee to act as a sex equity coordinator or officer, as applicable. The gender equity coordinator is to make all efforts to see that the educational body complies with and carries out its responsibilities under this act.
 Status: 053117 Ordered to the Assembly Re-ferred to the committees on Higher Education and Committee on Judiciary.
- SB-172, Portantino Health Care Coverage: Fertility preservation Support This bill would expand the definition of basic health care services to include standard fertility preservation services when a medically necessary treatment may directly or indirectly cause iatrogenic infertility. Status: 052517 Still in Senate. Held in the Appropriations Committee under submission.
- AB-23, Ridley-Thomas Education single gender academies Watch This bill will allow, under certain conditions, school districts to establish single gender schools and academies. This bill can take effect immediately as an urgency statute due to the students who have unique educational needs.

Status: 060117 Read for third time in the Assembly and ordered to the Senate. 070317 Currently in the Senate Committees on Education and Judiciary.

- AB-71, Chiu, Bonta, Kalra Income taxes: credit: low income & farmworkers housing Watch This act relates to taxation increasing the aggregate housing credit dollar amount that may be allocated among low income housing projects. An urgency clause allows this bill to take effect immediately. Status: 053017 Read second time. Currently in Committee on Appropriations
- AB-371, Cooley Sex Crimes: Communications with a minor Watch This bill would make it a crime to contact or communicate with a minor, or attempt to contact or communicate with a minor with the intent to commit human trafficking of the minor. This bill would impose a state-mandated local programs requiring the state to reimburse local agencies and school districts for certain costs mandated by the state. Status: 060817 In Senate, referred to Committee on Public Safety. 062017 Out of Committee on Public Safety and referred to Committee on Appropriations.

Our Determination Must Continue!

It is every mother's, grandmother's, mentor's and friend's dream that the women who come after her will have a better life than she experienced in terms of well being, health, and economic security. This has been true for women baby boomers who have experienced a 60% increase in many facets of life over their World War II counterparts.

Unfortunately, this is not holding true for today's young women, part of the Generation X and millennial groups. A report released in June by the Population Reference Bureau, a nonprofit that studies population and development, contained shocking findings. These women are poorer, more likely to commit suicide, experience higher rates of maternal mortality and are more likely to be kept out of high technology jobs than the generations before them. African Americans, Latinas, American Indian and Alaska Native women are particularly prone to experience negative outcomes.

The report reflected fourteen measures of well being. Study co-author Mark Mather related, "We expected to see that there would be certain subgroups of women that would be doing much worse than others, but we were surprised to find that women overall were doing worse than the previous generation."

BPW members who came before us worked hard to help women move forward in all aspects of life. Unequal pay, high costs of education and child care, and a dearth of women in public office are drivers in this unsettling state of women's lives. As members today, we must stay determined to accomplish BPW's goals so the dream of a better future will become a reality for tomorrow's members.

Women's Equality Day

At the behest of Rep. Bella Abzug (D-NY), in 1971 the U.S. Congress designated August 26 as "Women's Equality Day."

The date was selected to commemorate the 1920 certification of the 19th Amendment to the Constitution, granting women the right to vote. This was the culmination of a massive, peaceful civil rights movement by women that had its formal beginnings in 1848 at the world's first women's rights convention, in Seneca Falls, New York.

The observance of Women's Equality Day not only commemorates the passage of the 19th Amendment, but also calls attention to women's continuing efforts toward full equality. Workplaces, libraries, organizations, and public facilities now participate with Women's Equality Day programs, displays, video showings, or other activities.

Joint Resolution of Congress, 1971 Designating August 26 of each year as Women's Equality Day

WHEREAS, the women of the United States have been treated as second-class citizens and have not been entitled the full rights and privileges, public or private, legal or institutional, which are available to male citizens of the United States; and

WHEREAS, the women of the United States have united to assure that these rights and privileges are available to all citizens equally regardless of sex; and

WHEREAS, the women of the United States have designated August 26, the anniversary date of the certification of the Nineteenth Amendment, as symbol of the continued fight for equal rights: and

WHEREAS, the women of United States are to be commended and supported in their organizations and activities,

NOW, THEREFORE, BE IT RESOLVED, the Senate and House of Representatives of the United States of America in Congress assembled, that August 26th of each year is designated as Women's Equality Day, and the President is authorized and requested to issue a proclamation annually in commemoration of that day in 1920, on which the women of America were first given the right to vote, and that day in 1970, on which a nationwide demonstration for women's rights took place.
